Attorneys must also have demonstrated experience in, and knowledge of, the Federal Rules of Appellate Procedure, the Federal Rules of Civil Procedure, the Rules Governing § 2254 Cases, the Federal Rules of Evidence, and the Local Rules. Preference for the CJA Appeals/Habeas Panel shall be given to attorneys who have been in practice at least three years with experience in the field of criminal law and/or habeas corpus.
