NOTABLE CASES

Harrison v. Gillespie, No. 08-16602 (1-5-10). The state jury came back guilty on murder. As to the sentence, the jury reported that it was deadlocked, and two juror notes indicated that the deadlock was between life with parole, and life without. The petitioner asked to poll the juror on whether there was unanimous agreement whether aggravating circumstances existed and whether they found that mitigating circumstances outweighed aggravators. The trial court denied the request, and declared a mistrial. The State of Nevada sought to retry the petitioner on death, and he sought double jeopardy relief through habeas. The 9th (Reinhardt, joined by Hug) granted relief and reversed the district court's denial of the petition. The panel held the trial court abused its discretion by declaring a mistrial without first granting petitioner's request to poll the jury to determine whether it had acquitted petitioner of the death penalty. The panel further held that, because no other alternative would adequately protect petitioner's rights under the Double Jeopardy Clause, the State could not seek and the court could not impose the death penalty at a sentencing retrial.
