#### IN MEMORIAM: MABEL ADAMS

On October 1, Mabel Adams passed away at the age of 78. Mabel was the first Criminal Justice Act Panel Administrator for the Eastern District of California. She created the panel selection, supervision, and payment systems that we still use today and that remain the model for CJA panel management throughout the United States. Mabel joined the Federal Defender's office in January 1973. She served as the office receptionist, CJA manager, and secretary to then-Federal Defender E. Richard Walker. In 1990, Federal Defender Art Ruthenbeck convinced the Administrative Office of U.S. Courts to create the position of CJA Panel Manager and he fashioned the duties of this newly-created position after all the things Mabel was already doing. Although Mabel retired from the Federal Defender's office in 2000, several current members of the CJA panel were trained, administratively supervised, and aided by Mabel's guidance for many years. Mabel will be missed.

## **NOTABLE CASES**

U.S. v. Leal-Del Carmen, No. 11-50094 (9-14-12)(Kozinski, with Reinhardt & Fletcher). Government agents deported a witness who said that defendant was not an alien smuggler. They kept the other witnesses (who said he *was* a smuggler) in the country as material witnesses to testify at trial. The district court refused to dismiss the indictment or admit the video of the exculpatory witness's statement. It also refused to give a missing witness instruction. Defendant was convicted of alien smuggling. The Ninth Circuit reverses the conviction, holding that the government's wrongful deportation of the exculpatory witness, coupled with the evidentiary errors by the district court, deprived the defendant of a fair trial and of his constitutional right to present a defense.

Cudjo v. Ayers, No. 08-99028 (9-28-12)(N. Smith with Kozinski: dissent by O'Scannlain). In this death penalty habeas appeal, the Ninth Circuit grants relief because the state courts wrongly and unreasonably barred the petitioner from introducing trustworthy and exculpatory testimony that his brother, and not him, committed the murder. The evidence was a jail house confession, which the state trial judge kept out on reliability grounds. Under Chambers v. Mississippi, 410 US 284 (1973), the Court held that a defendant must be given a fair opportunity to defend himself. In Chambers the Supreme Court allowed a statement to be admitted that the state court had barred on supposed unreliable hearsay grounds. The state court made the same ruling here. The state courts were unreasonable in barring the confession, which could be attacked by the government for credibility. The reliability of the confession was a jury question. The fact that the prosecutor appealed to racial bias in his closing just added to the prejudice of the error.

Miles v. Martel, No. 10-15633 (9-28-12)(B. Fletcher, with Hug and Paez). The Ninth Circuit reverses the denial of a habeas petition and remands for an evidentiary hearing to determine whether the petitioner received IAC in rejecting a plea offer. The petitioner, a sympathetic military vet, faced a three-strike 25-to-life sentence for passing a fictitious check of around \$470. He claims his lawyer advised him to reject a six year plea offer because the priors would be dismissed by the court. The lawyer was wrong and the petitioner got 25-to-life. The hearing, under Lafler v. Cooper, 132 S. Ct. 1376 (2012), must determine whether counsel advised petitioner to reject the sixvear sentence and whether his advice was ineffective.
